We have continued to campaign

At our meeting in June we asked members to promote the idea of early years continuing until age 7 wherever they can - on social media, at conferences or in meetings. Flick Drummond MP, member of One Nation Conservatives, in the document The Future of Education promotes the idea that early years should continue until age 6. When she spoke at the Primary Umbrella Group meeting on the 14th June she asked for evidence to support her argument. She is prepared to challenge the (her) Government, Melian has written to her offering to work with her. ECF is in a good position to work with her on this. Peter Moss who presented the book he has edited with Claire Cameron 'Transforming Early Childhood in England ' to ECF members in January also argues for early years to continue to age 6.

We continue to be members of More than a Score campaigning against tests in the primary schools. Tests have of course been suspended in 2020 and 2021. However, unfortunately, as we know, as we know, Baseline Assessment is being reintroduced this September.

We have connected with the Royal Foundation and delighted to support its aims and aspirations.
